

## **EFFECTIVE DATE**

This bulletin is effective on issue.

## **PURPOSE**

The purpose of this bulletin is to notify all Workforce Development System (WDS) contractors and the public that the Economic and Workforce Development Department (EWDD) posted a draft of the Workforce Development Board's (WDB) Biennial Modification of the Local Plan for 2021-24 on February 24, 2023 to solicit public input on its contents.

## **NOTICE**

Under the Workforce Innovation and Opportunity Act (WIOA), a biennial update of regional and local plans is required to ensure that plans remain current and account for "changes in labor market and economic conditions or in other factors affecting the implementation of the local plan" (29 U.S. Code § 3123). The California Workforce Development Board (State Board) also makes changes to the California Unified Strategic Workforce Development Plan (State Plan) that require Local Boards to update their plans for consistency with the policy direction of the State Plan.

The EWDD has posted a draft version of its Local Plan Modification online for thirty (30) days to solicit the public's input, as required by WSD22-05, "Regional and Local Planning Guidance for PY 21-24 Two-Year Modifications," released October 27, 2022.
