This bulletin is effective upon date of issuance.

PURPOSE

The purpose of this bulletin is to notify all Workforce Development System (WDS) contractors and the public that the Economic and Workforce Development Department (EWDD) posted a draft of the Workforce Development Board's (WDB) Workforce Innovation and Opportunity Act (WIOA) Local Plan for Program Years (PY) 2025-28 on March 12, 2025 to solicit public input on its contents.

BACKGROUND

As outlined in WIOA Section 108, Local Plans provide an action plan for operationalizing the road map laid out in the Regional Plan by describing how individuals access services through the America's Job Centers of CaliforniaSM (AJCC) system. Local Plans are used to articulate by setting concrete goals, how Local Boards will coordinate with local partners to ensure person-centered service delivery. By utilizing robust partnership agreements, Local Boards can support the collaborative effort to achieve their shared vision. To develop comprehensive plans, the City of Los Angeles (City) seeks public comment on the Local Plan from WIOA core and non-core partners, state program partners, regional and local entities in various sectors, employers and worker representatives.

The EWDD has posted a draft version of its Local Plan online for a thirty (30) day-Public Comment period to solicit the public's input, as required by WSD24-09, "Regional and
